- Other sector agencies








### What sparqs does




- **Training and support** for student reps institutionally and nationally.






B.1 The board must have close regard to the voice of its students and the quality of the student experience should be central to all board decisions.

B.2 The board must lead by example in relation to openness, by ensuring that there is meaningful ongoing engagement and dialogue with students and the students' association in relation to the quality of the student experience.

#### The view from some student board members

"Sometimes board members use complicated language which makes fairly simple ideas more difficult to understand."

> "Board members will ask me 'what do students think about this?' It's not like I can just go out and ask them!"

"Being a board member is a valuable experience. I genuinely do feel like board members consider me an equal."

"The paperwork is really difficult to understand, especially the financial figures. It could be made a lot more accessible."

## Legislation concerning college students' associations

- Requirement to have a students' association which is run democratically (1992 & 1994 Acts)
- Two student members of a college board and Regional Board, nominated by the students' association. (2013 Act)
- Regional colleges and regional strategic bodies must seek to secure the collaboration of students' associations. (2013 Act)
- Regional colleges, regional strategic bodies, Scottish Ministers and the SFC have duties to consult students' associations. (2013 Act)



#### Putting Learners at the Centre, 2011

A Scottish government paper on its intentions for post-16 education in Scotland. It included:

- Outcome Agreements
- A focus on 'efficient learner journeys' (articulation)
- Student Partnership Agreements
- Reviews of college and university governance
- College regionalisation



#### Griggs Review

Recommendation 23 of the Griggs Review of college governance said that students' associations should be:

- Strong
- Autonomous
- Sustainable
- Appropriately funded

Working group set up to explore this more fully.




#### Development of the Framework

- Working group established by the Scottish Funding Council tasked with creating best practice guidance on creating strong students' associations
- The Scottish Government, Scottish Funding Council, and NUS Scotland led on the development of the Framework with the support of sparqs
- Four Strategic Dialogue Events were held in May 2014 with over 150 delegates from the sector
- Feedback on the final draft was sought from 70 stakeholders at Validation Events in January 2015.

# A Student Engagement Framework for Scotland

There are five key elements:

- 1. Students feeling part of a supportive institution.
- 2. Students engaging in their own learning.
- 3. Students working with their institution in shaping the direction of learning.
- 4. Formal mechanisms for quality and governance.
- 5. Influencing the student experience at national level.

The use of the term 'learning' throughout the framework can apply to learning, teaching and assessment.













# A Student Engagement Framework for Scotland

There are six features of effective student engagement:

- 1. A culture of engagement.
- 2. Students as partners.
- 3. Responding to diversity.
- 4. Valuing the student contribution.
- 5. Focus on enhancement and change.
- 6. Appropriate resources and support.
